Who is eligible for a mobiCard?

Persons who receive one of the following transfer payments can apply for a mobiCard from the Lüchow-Dannenberg district authority, department 60, with appropriate proof:

Basic income support under SGB XII, citizen's income under SGB II, child allowance, housing benefit, benefits under the Asylum Seekers Benefits Act (AsylbLG) or cost-of-living assistance under SGB XII

How long is my mobiCard valid?

The mobiCard is valid until the end of the calendar year in which the application is submitted and approved. If you are still entitled to a mobiCard in the following year, you must submit a new application for the following year in December. Automatic renewal of the mobiCard is not possible.

What are the advantages of the mobiCard?

The mobiCard entitles you to purchase tickets in price group 2 of the Wendland tariff of LSE GmbH. This also applies to annual tickets, which can be applied for online at www.mobil-im-wendland.de. Depending on the type of ticket you choose, you will receive a discount of up to approx. 50% compared to price group 1.

How much does the mobiCard cost?

There are no costs for issuing the mobiCard. The mobiCard is free of charge.

Where can I apply for the mobiCard?
